Baseline Emissions Footprint

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that scope 1 and 2 carbon emissions will decrease over the next five years to 40.00 tCO₂e by 2030. This is a reduction of 57.35% from the baseline.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2020 baseline. The carbon emission reduction achieved by these schemes equate to 41.8 tCO₂e, a 55.43%ge reduction against the 2020 baseline and the measures will be in effect when performing the contract.

The environmental management measures we have put in place since the baseline year include a full rewiring of the factory and premises which included upgrading all lights to LED lighting, as well as commenced the electrification of our fleet of vehicles, and the installation of solar panels.

In the future we hope to implement further measures such as:

Further electrification of the company's fleet

Introduction of cycle to work scheme

Further solar panel work

Replace laser cutting machine with a more efficient model
