### Commitment to achieving Net Zero

BMM Weston Limited is committed to achieving Net Zero emissions by 2050.

### Baseline Emissions Footprint

## Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 700.00 tCO<sub>2</sub>e by 2028. This is a reduction of 14.81%

## Carbon Reduction Projects

### Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2020 baseline. The carbon emission reduction achieved by these schemes equate to 18 tCO<sub>2</sub>e, a 19.2%ge reduction against the 2020 baseline and the measures will be in effect when performing the contract.

The environmental management measures we have put in place since the baseline year include a full rewiring of the factory and premises which included upgrading all lights to LED lighting, as well as commenced the electrification of our fleet of vehicles.

In the future we hope to implement further measures such as:

Installation of solar panels

Further electrification of the company's fleet

Introduction of cycle to work scheme
